### RULES OF THE DOG SPLASH

All dogs must be pre-registered and have proof of current vaccinations (rabies, distemper, parvo virus and bordetella). Your veterinarian can provide this form to you.

All dogs must remain leashed while outside of the fenced-in lake area. Your dog must remain under your control at all times.

Know your dog's personality. If your dog is showing aggression, please wait until you can calm him/her down before unleashing. If your dog continues to act aggressively, you and your dog may be escorted from the area.

No children under the age of 12 are allowed in the area without adult supervision.

Female dogs in heat are not permitted.

Puppies under the age of 12 weeks are not permitted.

Do not bring dogs that have health conditions that may endanger themselves or others.

Humans are not allowed in the lake with the dogs.

Outside food or drink (pet or human) is not allowed in the lake area.

Please be sure that your dog has been exposed to swimming prior to the Dog Splash. Dogs don't automatically know how to swim. Fear and anxiety around water can lead to aggression.

Your dog may need help getting out of the lake. Volunteers will be on hand to help if necessary.

Be courteous to other guests and clean up your dog's "accidents." Plastic bags will be available for your use.

Please notify a City of Peekskill employee or a Dog Park Advisory Board staff person if you notice an aggressive dog or a dangerous situation. We want to keep the Dog Splash safe and fun for everyone.

The City of Peekskill's Animal Control officer will be on duty during the Dog Splash.

### RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I acknowledge that I voluntarily have applied to participate and use, with my dog(s), the Depew Park Lake ("the lake") for this dog swimming event ("the Dog Splash") on September 18, 2010.

I understand that the act of unleashing my dog(s) and being physically present at the lake necessarily involves risks of injury to me, to other people, to my dog(s), and to other dogs. I understand these risks are entirely my responsibility. I expressly assume these risks.

I am aware of the risks and hazards inherent upon entering the lake area and I choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for myself and/or my dog(s) and I voluntarily assume all such risks, loss, damages or injury that may be sustained by entering the lake.

By signing this release of liability and using the lake, I hereby fully and forever release and discharge the City of Peekskill, NY, and the Peekskill Dog Park Advisory Board and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of the lake. I fully and forever release and discharge the City of Peekskill, NY, and the Peekskill Dog Park Advisory Board and their volunteers, employees and agents from any and all negligent acts and omissions in the same.

By signing this agreement I also agree to indemnify the City of Peekskill, NY, the Peekskill Dog Park Advisory Board and their volunteers, employees and agents from any claims, demands, damages, rights of action or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, brought against any or all of such entities based on my use of, and intended use of, the lake during this event.

I have carefully read this release of liability and understand and fully agree with its contents.
